- 2. ASSUMPTION OF RISK. I AM AWARE AND UNDERSTAND THAT, IN GENERAL, MARTIAL ARTS IS A DANGEROUS AND HAZARDOUS ACTIVITY, AND IN PARTICULAR THE INSTRUCTION, TECHNIQUES TAUGHT AT TRIDENT ACADEMY OF MARTIAL ARTS, INC. (COLLECTIVELY, TRIDENT MARTIAL ARTS METHODS), I AM VOLUNTARILY AND OF MY OWN FREE WILL PARTICIPATING WITH FULL KNOWLEDGE AND UNDERSTANDING OF THE SERIOUS DANGER AND HAZARDS INVOLVED. I HEREBY CONSENT AND AGREE TO COMPLETELY ACCEPT ALONE ANY AND ALL RISKS OF INJURY OR DEATH, AND I VERIFY AND CONFIRM THIS STATEMENT BY PLACING MY INITIALS HERE:
- 3. Release. In consideration of (a) being accepted as a member of the Trident Academy of Martial Arts, Inc. (b) being instructed of and about Trident Academy of Martial Arts, Inc. methods (c) being entitled to participate in any and all of the activities conducted or sponsored by the Trident Academy of Martial Arts, Inc., and (d) being permitted to use any and all of the Trident Academy of Martial Arts, Inc. equipment, whether owned or leased by the Trident Academy of Martial Arts, Inc., in connection with the Trident Academy of Martial Arts, Inc. methods, its activities, or otherwise, I hereby agree that I, my heirs, distributes. guardians, successors in interest and legal representatives (collectively referred to as "Releasor") will not make a claim or file an action or suit against, sue or attach the property of (a) the Trident Academy of Martial Arts, Inc, and/or any of their respective affiliated organizations, and (b) any and all manufacturers, distributors, wholesalers, suppliers, retailers, and/or providers of the facilities and equipment I will use in connection with activities conducted and /or sponsored by the Trident Academy of Martial Arts, Inc. and its activities (collectively referred to as the "suppliers"), (the Complete Sponsors and the Suppliers shall collectively be referred to a "Releasees"), for damages, injury, emotional distress claims, bodily injury claims, and punitive damages, whether known or unknown, foreseen or not due to resulting from the acts, conduct, negligence, or misfeasance of, or failures to act by, the Releasees, or any them.
